### **2017 ANNUAL FALL MEETING**

### SUMMARY OF MEETING

September 27, 2017

The National Coal Council convened for its annual Fall meeting, which was held pursuant to Notice and Invitation at Salon C, Renaissance Ross Bridge Resort, 4000 Grand Avenue, Birmingham, Alabama, USA, commencing on the September 27, 2017, at 8:38 a.m. CT.

#### WELCOME

Greg Workman provided the Welcome Address to the group. He spoke on the number of representatives from the Department of Energy in attendance at this meeting, including Dr. Grace Bochenek as the DOE Keynote speaker. He listed the other reports and presentations on the agenda and noted the program will end with Council business. He also noted that at the conclusion of the program there will be a tour of the National Carbon Capture Center.

He noted that this meeting is being held in accordance with the Federal Advisory Committee Act, and the Regulations that govern that Act. The meeting is open to the public. Guests from the public are welcome and an opportunity will be provided for comment at the end of the meeting.

Greg Workman asked for a motion to adopt the Agenda. Ram Narula provided the first motion; Jerry Oliver provided the second motion. All in favor. No opposed.

#### ANTITRUST ADVISORY

Julia d'Hemecourt provided the Antitrust Advisory. The NCC is a Federal Advisory Committee to the Secretary of Energy and membership conifers no immunity from federal or state antitrust laws. Grace M. Bochenek provided the U.S. Department of Energy Keynote Presentation. She noted the history of NETL with the NCC, over a decade. She pointed out the importance of fossil fuels and the need for new technologies in the coal-powered industry.
