WEBCAST ON NCC REPORT "COAL POWER: SMART POLICIES IN SUPPORT OF STRONGER, CLEANER ENERGY"

SUMMARY OF MEETING

July 16, 2020

The National Coal Conference held its "Coal Power" report meeting on Thursday, July 16, 2020 from 12:00–1:00 p.m. ET via WebEx.

Call to Order

Tom Sarkus called the National Coal Council meeting to order. He introduced himself along with Joe Giove as the Deputy Designated Federal Officers of the National Coal Council in support of the Secretary Steve Winberg, the Designated Federal Officer. He stated that he will be managing the meeting on behalf of the Department of Energy. He also stated that Joe Giove is listening to the meeting and Steve Winberg may be joining in momentarily.

Tom Sarkus welcomed all of the members who are on the call as well as the DOE, NETL, media, and general public.

Opening Remarks

Tom Sarkus continued with a housekeeping announcement. The sole purpose of the meeting is to discuss the final draft of the report that NCC has been working on the past year, conduct a vote, and finalize the report. He mentioned that everyone will be on mute, but will get to participate during the meeting for questions via the chat box function. Tom Sarkus stated that after the presentation, Janet Gellici would address any questions on the draft report based on the questions entered into the chat box. Kipp Coddington and John Harju, co-chairs of the report are on standby to assist Janet Gellici in answering questions.

Tom Sarkus alerted the NCC members to pay close attention on the window as poll question will be posted. He also mentioned that NCC members are required to vote on the poll in order to issue the report. The poll will remain open during Janet Gellici's presentation and the question and answer session.

Tom Sarkus called on NCC, Inc. legal counsel, Eric Hutchins, to provide an important anti-trust advisory.

Anti-Trust Advisory

Eric Hutchins stated that the NCC is a federal advisory committee to the Secretary of Energy. Membership in the organization confers no immunity from federal or state anti-trust laws. NCC has a set of general anti-trust guidelines, and copies can be forwarded.

Designated Response Opportunity Advisory

Tom Sarkus noted that this meeting is being held in accordance with the Federal Advisory Committee Act (FACA), and the Regulations that govern the implementation of the Act. Full recording is being made and will be posted on the internet after the meeting is completed. Guests from the public are welcome and an opportunity will be provided for comment at the end of the meeting. The Federal Register Notice stated that if anyone from the public wished to have a statement read during this meeting, they could send it to the Deputy Designated Federal Officers by 5:00 p.m. on July 13, 2020. Tom Sarkus attested that no requests for the written comment or verbal comment were received.

NCC Report Presentation

Janet Gellici gave a presentation on the draft report. The request for the report was received in the Summer of 2019 from former Energy Secretary Rick Perry to focus on policies and highlight specific power sector technologies for existing and new coal generation, regulation and legislation of states and public utility commissions, and energy infrastructure issues.

She continued with the chapters of the report "Coal Power: Smart Policies in Support of Stronger, Cleaner Energy."

Janet Gellici wrapped up the presentation and opened the floor for questions and suggestions..

Questions/Comments

Tom Sarkus called for questions to be posted via the chat box and sent to panelists. Questions and suggestions were taken and noted.

NCC Membership Vote on Issuing Report

Tom Sarkus reminded participants to vote on whether to issue the report or otherwise. After the vote, NCC members are welcome to submit any supplementary comments by close of business on July 23, 2020, by emailing Janet Gellici. He also mentioned that the comments will be attached to the report in an Appendix. He reminded members to respond to the poll. Those who were not able to vote through WebEx can utilize the chat box or contact Janet Gellici to vote.

Tom Sarkus noted that Angelos Kokkinos from the DOE Office of Fossil Energy and Brian Anderson from NETL are also on the call.

The results of the vote were in favor of publishing the report. For a breakdown of how each member voted, please see Appendix B.

Tom Sarkus stated that no public comments were received. He thanked everyone who provided support to the NCC for their efforts.
